Example projects: LINK: USAID-funded program Policy LINK strengthens the leadership capacity of public, private, and civil society actors and fosters collective action among them to transform policy systems. We support data insights for collective impact, system sensing and strategic design, learning design and activation and collaborative policy-making. As a strategic learning partner, we co-lead action research aimed at helping stakeholders engage in cross-country dialogue and learning about indicators of agricultural progress and strategies that are working well. GKI makes sense of complex issues through research and data visualization to illuminate options, opportunities, and threats. Example projects: (FAO) NENA Food Systems Research: The Near East and North Africa Region's food systems have been affected by political unrest, environmental degradation, shifting demographics, and more. GKI partnered with FAORNE to conduct research and report our findings on viable innovations with the most potential to advance SDG 2 (Zero Hunger).
