Example projects: CCIR : GKI designed and managed the Caribbean Corporate Investment Initiative (CCIR) program, building collaboration opportunities for governments, businesses, and communities across the Caribbean, to come together to identify, develop and scale innovative, sustainable solutions to systemic challenges around disaster resilience.

4b (Code:) (Expenses \$ 81,460 including grants of \$) (Revenue \$ 85,396) Research : GKI makes sense of complex issues through research and data visualization to illuminate options, opportunities, and threats. Systemic research allows analysis of the entire system from a range of actors' perspectives, helping users understand the context of the problem and the dynamic relationships between actors, as well as the interplay between interventions and change outcomes. Example projects: SPACES - SPACES - Building Healthy Cities (BHC) Initiative: GKI worked to undertake systems research to assess the change in stakeholders and the system brought about by participation in engagements hosted by the BHC programs.

Example projects: FTF Innovation Labs: GKI designed and launched, facilitated and managed, and transitioned the Innovation Labs (IL) community of practice (CoP) over this activity's period of performance (PoP). The Network was designed to reduce the transaction costs to generate, incentivize and enable knowledge sharing and learning among CoP members from across USAID-funded Feed and the Future Innovation Labs, on cross-cutting issues namely integrating local capacity development and gender considerations into agriculture research investment and efforts.
